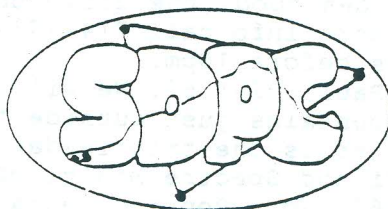
Hiker of the Month

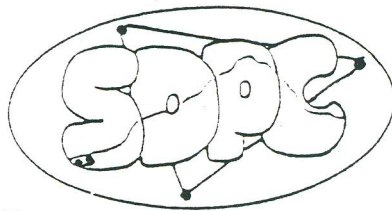

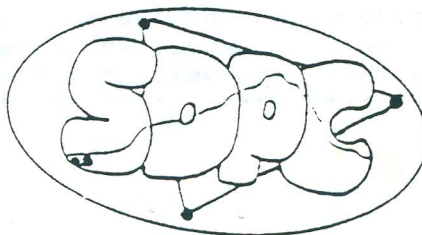
The hikes with the star (*) are appropriate for the bird woman to bring her hiking stick with her.

- Jan 11-12 Sombrero Peak and Tule Mtn. Dennis Richards 462-3643. Dennis will do these peaks from McCain Valley with an overnight at Cottonwood campground. (Schad p.254) Saturday's hike is 6 hrs RT. Sunday's hike up Tule is 2½ hrs RT.
- Jan 11-12 DPS. Mitchell, Edgar and Providence Pt. Hike above the beautiful Mitchell caverns. Strenuous. Paul 692-1367. The drive is 4½ hrs to near Needles. Don't know why I like this climb. Perhaps it's because I got to see the caverns. Perhaps because it's a nice hike, or perhaps because I got to meet Ang Karma Sherpa (who climbed Everest) on my last trip.
- Jan 18 SDO. Dead Indian Wash. Palm Desert. Paul 692-1367. This is a new orienteering site.
- Jan 19 * Mecca Hills. Palm Desert. Paul 692-1367. Come out for the day or spend the weekend (3 hrs drive). Wes Shelberg showed me the route on this amazing maze of mud hills. Everyone always considers this one of their favorite hikes! Yes, it is that good! Two separate hikes, a 3 hr RT and a 2 hr RT, make for a fun day. Both hikes are easy, and I encourage spouses to come along. The pace will be easy.
- Jan 25 Coyote Canyon Clunker Classic Mountain Bike ride! Meet in Borrego at Christmas Circle, load your bikes onto the U-Haul trucks, and load your body onto one of 5 buses for the drive up to the top of Coyote Canyon at Anza for the 32 mile ride back to the Circle. Normal riding time is 3-4 hours (fastest is under 2, but who wants to do that!). You arrive back to an Elliott-famous "all you can stand" barbeque. Plus you are now sporting your new Clunker Classic T-shirt! Very trendy! All for \$40. 300 riders rode last year (latecomers were turned away, so enter early!) Entry form in this newsletter.
- Jan 26 * Red Top and Pepperwood trail hike. Paul 692-1367. This is a combination hike to help Steve Spiller finish all the hikes in Jerry's book. He has less than a half-dozen left to do. (Schad p.259). We will start in McCain Valley and drop down to Canebrake wash where Paul's group will climb Red Top and Steve's group will finish Jerry's described trip. Steve's trip is moderate and Paul's is strenuous. Five people have climbed Red Top since 1978 (Gordon MacLeod, Barbara Reber, Wes Shelberg, Al Holden and Paul). Add your name!
- Feb 7-10 Canon Providencia, Sierra San Pedro Martir, to ten tier waterfall. Class 3-4, extremely remote and strenuous backpack. Carl Johnson 448-8542. (But Carl, you're not an advanced COL, hee hee hee).
- Feb 8-16 Baja Whale Watch trip. Ron and Leora Jones have put this trip together with Adventure Travel guide and friend, Elden Kidd. (Those watchers of American Gladiators may remember Elden as a finalist a couple years ago). Ron knows more treasure places "away from the crowd" than anyone I know. Elden is one of the most interesting people I know. The cost of \$650 includes food, the drive down and flight back from La Paz. For more info call 714-773-5570 mornings from 6-9am and evenings before 10pm.
- Feb 15-16 DPS. Silver Mtn. Paul 692-1367. We will flirt with illegality by climbing the mountains just outside the China Lake Weapons Center. A BLM ranger is the trip leader.
- Feb 22-23 DPS. Chili cookoff and Spectre Mtn climb (past Joshua Tree). Paul 692-1367. Join Ron and Leora Jones for the 2nd annual cookoff. Last year we had 5-6 kinds of chili and 15 tasters. Practice up on your horseshoes, we had an exciting climax to last year's event! Climb is Sunday.

- Feb 29 San Diego River (Schad p.96). Carl Johnson 448-8542. Meet at 6:09am in Ramona for this 11 hr hike. See where Jim Sugg was bitten by the rattler! Strenuous. 10½ mi.
- Mar 1 * Iron Mtn. Paul 692-1367. Easy local Poway trail hike. 10 miles, 5 hrs. Loop hike. Gee, we will be doing this 10 miles over 6 hours faster than yesterday's 10 mile hike. *7AM START*
- Mar 14-15 Canoe trip!!!!!! This will be my 3rd annual trip on the Colorado river. This will complete the third in a trilogy of trips. The first featured hot springs by Hoover Dam, the second featured petroglyphs in the Topock Gorge by Needles, now we move downstream to around Yuma. This trip will have two full days (18 mi each day) of canoeing, which is much more than my trips usually do; but Carl Johnson, Beth Davis and Robin Tucker all say it is a very lovely trip. Trip fee includes canoe rental, five sumptuous meals and a cook to culinize the cuisine starting at breakfast on Sat and ending at lunch on Sunday. The feast will include blueberry pancakes, eggs, and Hillshire sausage sauted in onions and mushrooms, orange juice and coffee. For dinner we have steaks, chicken and pasta (in, of course, pasta sauce). Soda pop, beer and wine is included. Fee is \$75. The fee does not include \$35 per car for shuttling costs. This is because it is such a long way betwixt the beginning (Walter's Camp), and the end (Martinez Lake). Driving time from SD is 4 hours. Paul 692-1367. Calling me doesn't reserve a spot, sending me payment in full does! I will return any monies I can, if you change your mind, but I don't know what the canoe rental refund policies are yet. I think I'll throw in a \$5 nonrefundable clause.
- Mar 21-22 Canon Palomar. Baja. Carl Johnson 448-8542. Richard Hughes assisting. Carl is going to do this canyon instead of Tajo. It is the next canyon. They will be leaving on Friday. Strenuous backpack. Carl promises spectacular scenery with a possible hot spring side trip!
- Mar 22 * Pyramid and the Wonderstone trail (Schad p.207). Paul 692-1367. This is the second of three hikes designed to help Steve Spiller finish Jerry's book. I didn't think it was that hard, but Jerry sez 11 mi, 4000 foot gain, 10 hrs.
- Mar 28 * 6K Ridge. By Burnt Rancheria in Lagunas. Paul 692-1367. Al Holden designed this hike. One of the best in the Lagunas! Jim Sugg's group has done it, so I know everyone who is in SDPC can do it. It takes about 5 hours. Hopefully we can do it without the thunderstorm that hit us the first time we did the trip. We were wet puppies.
- Mar 29 Pinyon Mtn- North approach. (Schad p.229). Paul 692-1367. Join us as Steve Spiller closes the book on Jerry's hikes. Jerry sez 3100 ft, 14 mi, 10 hrs for this desert trip. I say champagne on the peak! Help Steve celebrate!!!!

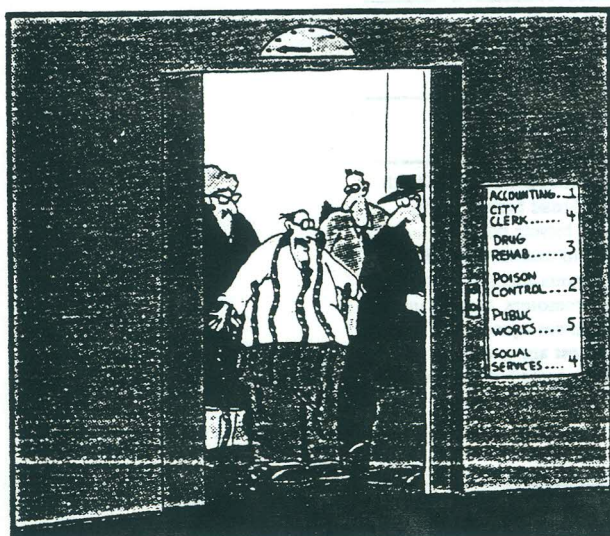

As lawful consideration for being permitted by the SAN DIEGO PEAKS CLUB or any of its officers, agents, servants, volunteers, activity participants, or employees, herein referred to as releasees, to participate in these activities and/or use their equipment, the undersigned does for him/herself, his/her heirs, executors, administrators, legal representatives, guardians, distributees, and assigns, collectively referred to as releasors, hereby release, waive, discharge and relinquish any action or causes of action for personal injury, property damage, or wrongful death which may hereafter arise from the activities or any pursuit incidental thereto wherever or however said pursuit may occur and for whatever period said activities and pursuits may continue. The undersigned further agrees that under no circumstances will the releasors prosecute or present any claim against releasees for any causes of action, for personal injury, property damage or wrongful death, whether the same shall arise by the negligence or non-intentional conduct of any of said releasees from the activities or any pursuit incidental thereto.

The undersigned and the remaining releasors hereby agree to indemnify, save and hold harmless the releasees and each of them from any loss, liability, damage or cost (including attorney fees) which releasees may incur as a result of injury, death or property damage to the undersigned

This document is intended to be as broad as is permissible under the law of the State of California and this agreement shall be interpreted under the laws of the State of California. If any portion of this agreement is invalid, it is agreed that the balance shall continue in full force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement and further agrees that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.
